Outcome: Identify different breeds of cattle, their means of selection and importance of a dairy farmer

Theory Content:

- Explain general discipline to be maintained in the class room & field. (Do's & Don'ts)
- Explain the role of a Dairy Farmer
- Identify different indigenous and exotic breeds of cattle.
- Identify the high milk yielding varieties.
- Demonstrate ways of selection of cattle.
- Explain means of differentiating healthy and sick animals.
- Trainee will be able to learn and practice basic reading capabilities to enable reading of signs, notices and/or cautions at site.

Practical Content:

Module No. 2: Illustrate ways of identifying and maintaining livestock accommodation, equipment, materials and waste.

Outcome: Illustrate ways of identifying and maintaining livestock accommodation, equipment, materials and waste.

Theory Content:

- Prepare animal accommodation which achieves the best balance between animal health and well-being and available resources, consistent with relevant legislation
- Prepare and maintain equipment, tools and materials required for livestock accommodation
- Follow cleaning routine in accordance with supervisor' instructions.
- Dispose of waste according to established workplace procedures
- Report any hazards identified, to the supervisor immediately
- Maintain accommodation in a safe and clean condition for livestock

- Replenish materials and supplies as required by livestock
- Clean tools and equipment and maintain according to established workplace procedures
- Store equipment safely and securely in the assigned location
- Use working methods and systems which promote health and safety and which are consistent with relevant legislation and codes of practice
- Take the appropriate action when monitoring reveals problems or issues with the accommodation

Practical Content:

- Layout of houses for dairy animals – conventional housing and loose housing
- Prepare and maintain equipment, tools and materials required for livestock accommodation
- Dispose of waste according to established workplace procedures
- Cleaning and disinfection of cowshed

Tools & Equipment needed:

Module No. 3 Explain all the ways suitable to establish livestock within the accommodation, maintaining their health, cleanliness, safety and minimum stress

Outcome: Explain all the ways suitable to establish livestock within the accommodation, maintaining their health, cleanliness, safety and minimum stress

Theory Content:

- Wear suitable personal protective equipment when establishing livestock in their accommodation
 - Check that the equipment, materials and accommodation are suitable for reception of the livestock, prior to their arrival
 - Establish suitable environmental conditions for the animals
 - Handle and move the livestock correctly and safely, according to supervisor's instructions
 - Introduce livestock into the accommodation in a way that minimizes stress and maintains their health and welfare
 - Deal with any difficulties arising according to established workplace procedures
 - Carry out your work according to relevant legislation and codes of practice.
 - Monitor the livestock carefully, to ensure their ongoing health and welfare is maintained
 - Monitor environmental conditions carefully to ensure that they promote the health and well-being of livestock
 - Adjust and replenish materials as required by the livestock
 - Arrange for regular cleaning of animal housing areas, floors and mats of animals (if any) according to the animal accommodation and specification
 - Carry out cleaning routines of animals as per prescribed procedures.
 - Arrange for regular disposal of animal waste and other wastes as per prescribed procedures
- Report problems that cannot be dealt with to the supervisor immediately

Practical Content:

- Wear suitable personal protective equipment when establishing livestock in their accommodation
- Check that the equipment, materials and accommodation are suitable for reception of the livestock, prior to their arrival
- Handle and move the livestock correctly and safely

- Arrange for regular cleaning of animal housing areas, floors and mats of animals (if any) according to the animal accommodation and specification

Tools & Equipment needed:

Module No. 4 Explain different ways of preparing, providing, storing & maintaining the feed and water for livestock.

Outcome: Explain different ways of preparing, providing, storing & maintaining the feed and water for livestock

Theory Content:

- check that the correct quantities and types of animal feed have been delivered and that they are in an acceptable condition
 - Report any shortfalls or faults in delivered animal feed to the appropriate person
 - Handle animal feed safely, and in a way that protects it from damage and contamination and minimizes wastage
 - Store animal feed safely according to the manufacturer's recommendations, in the order in which it is to be used
 - Check stored animal feed regularly for any signs of pest infestation and report this to the appropriate person straight away
 - Check stock levels regularly and tell the appropriate person if stocks are low.
 - Wash hands effectively before and after handling animal feed
 - Obtain the equipment and materials needed to prepare and serve animal feed
 - Clean work surfaces, utensils and equipment effectively before and after use
 - Arrange for various feed and feed supplements essential for animal nutrition and growth
 - Mix the appropriate proportions of feed and feed supplements depending on the age and stage of growth of animal
 - Prepare the correct amount of animal feed as directed in the Feeding Plan in a way that minimizes wastage
 - Operation and maintenance of equipment used in feed preparation e.g. chaff cutter
 - Use working methods and practices throughout the process that promote health and safety
 - Dispose off any stale and unusable animal feed in a safe place and put equipment and utensils away safely
 - Wear suitable personal protective equipment when providing feed and water to livestock
 - Supply feed to livestock according to established workplace procedures
 - Supply clean, fresh water to the animals according to their needs
 - Report concerns, related to the feeding and drinking habits of animals, to the supervisor immediately
 - Monitor the condition of feed and water and take the appropriate action when problems occur
 - Clean and maintain feed and water equipment according to established workplace procedures
- Dispose of waste from the feeding and watering systems safely and correctly, according to established workplace procedures

- Check that the correct quantities and types of animal feed
- Handle animal feed safely
- Store animal feed safely according to the manufacturer's recommendations
- Check stored animal feed regularly for any signs of pest infestation.
- Check stock levels regularly
- Wash hands effectively before and after handling animal feed

Theory Content:

- Treat animals in a manner which complies with relevant legislation, minimizes any likelihood of stress and injury, and maintains their health and well-being
- Provide animals with sufficient and effective opportunities to move, and maintain physical functioning
- Monitor the physical condition of the animals at suitable intervals, and recognize, record and report any abnormal signs
- Check livestock for presence of external parasites
- Carry out specific measures to promote and maintain animals' health and welfare correctly and safely
- Ensure records are accurate, legible and complete and comply with organizational and legal requirements for future reference
- Immediately summon assistance for any animals health emergency, and initiate action appropriate to the situation
- Manage waste safely and correctly in accordance with legislative requirements.
- Use and store drugs, medication and equipment in accordance with veterinary instructions and organizational policy
- Use current and uncontaminated prescribed medication only for the intended animal
- Use the correct technique to give the specified treatment at the correct time
- Report any difficulties, in administering treatments, immediately to the supervisor
- Complete records of the treatment accurately, according to established workplace procedures
- Observe livestock after treatments and report concerns immediately to the supervisor

Practical Content:

- Monitor the physical condition of the animals at suitable intervals, and recognize, record and report any abnormal signs
- Check livestock for presence of external parasites
- Use and store drugs, medication and equipment in accordance with veterinary instructions and organizational policy
- Use current and uncontaminated prescribed medication only for the intended animal
- Use the correct technique to give the specified treatment at the correct time
- Methods of administration of drugs

Tools & Equipment needed:

Module No. 6: Demonstrate hand and machine milking procedure, along with identification of the equipment used, means of handling, storing & evaluating the quality of milk

Outcome: Demonstrate hand and machine milking procedure, along with identification of the equipment used, means of handling, storing & evaluating the quality of milk.

Theory Content:

- Maintain conducive milking environment
- Restrain the cow in preparing her for milking
- Prepare Udder before milking
- Check for mastitis
- Check and Adjust milking equipment, as required, to ensure correct operating order
- Carry out livestock health treatments during drying off, as directed, with minimal stress and weight loss
- Perform Milking using the right technique
- Establish a calm regular milking routine
- Implement milking procedures with minimum stress to livestock and maximum yield within reasonable timeframes
- Rectify Minor malfunctions of equipment or milking systems are rectified to manufacturer's specifications, and more complex repairs are reported for specialist attention
- Implement prescribed handling practices so as to prevent cross-infection during milking operations
- Perform Teat dipping to prevent mastitis
- Weigh and store the milk into milk can
- Clean the milking pail and keep them in the designated place

Practical Content:

- Milking of animals and care of udder
- Handling of milk
- Field test to evaluate bacteriological quality of milk
- Determination of common milk adulterants – glucose, cane sugar, starch
- Determination of fat percentage of milk
- Determination of SNF of milk

Tools & Equipment needed:

Module No. 7: Illustrate ways of identifying, conserving, storing, packing, using of animal fodder along with maintenance of fodder equipment

Outcome: Illustrate ways of identifying, conserving, storing, packing, using of animal fodder along with maintenance of fodder equipment

Theory Content:

- Explore various forage conservation options based on the year round requirement of feed and fodder
- Identify risk factors for spoilage in forage conservation such as fire, vermin and air in silage
- Ensure favorable conditions suitable for forage conservation
- Prepare forage conservation machinery and equipment in accordance with manufacturer's specifications, Occupational Health and Safety (OHS) requirements
- Ensure clear access to paddocks for harvesting and transport machinery
- Prepare storage facility for selected forage conservation method
- Identify safety hazards and implement OHS procedures for forage conservation
- Monitor weather conditions to determine optimum time for harvest and to ensure quality.
- Identify dry matter target and assess dry matter content of forage material for the forage operation

- Mow, condition, tender and/or rake swaths depending on weather conditions and forage drying targets
- Conduct harvesting activities in a safe, controlled and efficient manner.
- Check equipment during harvesting operations regularly for wear and damage
- Bale, wrap, compact, seal or store forage in accordance with storage plan.
- Load, transport, and store/compact (if required) forage in accordance with OHS and quality requirements
- Store forage so as to minimize risk of spoilage and combustion
- Dispose of all waste and debris to minimize environmental impacts
- Clean and service machinery and ancillary equipment in accordance with manufacturer's specifications, OHS requirements and industry practice
- Test or sample stored forage for quality
- Mitigate environmental impacts of forage conservation activities such as effluent run off, if any

- Read and understand the hazards of use and contamination mentioned on the labels of pesticides/fumigants etc.
- Assess risks prior to performing manual handling jobs, and work according to currently recommended safe practice
- Use equipment and materials safely and correctly and return the same to designated storage when not in use
- Dispose of waste safely and correctly in a designated area
- Recognize risks to bystanders and take action to reduce risk associated with jobs in the workplace
- Perform your work in a manner which minimizes environmental damage all procedures and work instructions for controlling risk are followed closely
- Report any accidents, incidents or problems without delay to an appropriate person and take necessary immediate action to reduce further danger.
- Follow procedures for dealing with accidents, fires and emergencies, including communicating location and directions to emergency
- Follow emergency procedures to company standard / workplace requirement
- Use emergency equipment in accordance with manufacturers' specifications and workplace requirements

- Provide treatment appropriate to the patient's injuries in accordance with recognized first aid techniques
- recover (if practical), clean, inspect/test, refurbish, replace and store the first aid equipment as appropriate
- Report details of first aid administered in accordance with workplace procedures
