NOTIFICATION

Submission of Eligibility Documents of all the admitted students, including Management Quota, of Diploma in Engineering & Technology, for the Academic session 2025-26 at Karigari Bhavan, Rajarhat

Principals/ Principals-in-Charge/ Instritutional Heads of all the Diploma in Engineering & Technology Institutions, affiliated under WBSCTVESD for 2025-26, are requested to submit hard copy of admitted students list and their eligibility documents (photocopy of Aadhar card, Class 10 markssheet, admit Card, etc) to the Council office at Newtown, Rajarhat, positively by 24th November, 2025.

Students list and eligibility documents must be submitted in the following manner:

- 1. Students' names in the list should be in alphabetical order (department wise), placed on the top of the eligibility documents inside the four-folded file
- Admission eligibility documents of each student should be stappled as a bunch. Each bunch should carry all eligibility documents. No subsequent submission of loose documents shall be allowed.
- 3. Such bunches should be arranged in the same alphabetical order of the students list.
- 4. All the above documents must be placed inside a four-fold file properly labelled with Institutute Name, Code and District.

It is the responsibility of the candidate / institute to ensure that the eligibility criteria is as prescribed by AICTE, failing which their registration will be cancelled.

Registration certificate will be issued only to the validated (approved & registered) students of respective Polytechnics/Institutions. Principal/ Principal-incharge/Institutional Heads are requested to take note of the above and do the needful.

Student Eligibility Criteria essential for Registration in 2025-26

A. For candidates taking admission in 1st Year:

- Candidates must pass Madhyamik Examination from West Bengal Board of Secondary Education or
 its equivalent examination from Council recognised Board/Council (For this purpose, Mark Sheet
 of the qualifying examination of the candidate shall be checked)
- There is no upper age limit. However, the candidate should not be born after **01.07.2010**. (For the purpose, Admit Card or Certificate of the qualifying examination or Birth Registration Certificate of the candidate shall be checked).

B. For candidates taking admission in 2nd Year:

Candidates must pass any one of the following examinations: -

Candidates must pass HS (Vocational) of WBSCT&VE&SD

OR

 Candidates must pass 10+2 examination from the recognized Board/Council, with any one of the subjects/areas of Physics / Mathematics / Chemistry / Computer Science / Electronics / Information Technology / Biology / Informatics Practices / Biotechnology/ Technical Vocational Subject / Agriculture / Engineering Graphics / Business Studies /Entrepreneurship

OR

Candidates must pass 10th class + (2 years ITI, continuous), in annual system or semester system, in any branch of Engineering and Technology.
 (For this purpose, 2 years combined mark sheet of the quatifying examination and Admit card of the candidate shall be checked) There is no age limit.

Note: Incase of any minor discrepancy in the name of the candidate (verified within the eligibility documents, the same must be either corrected from the relevant department or authorized by the submission of an affidavit from First Class Judicial Magistrate or First-Class Executive Magistrate from the district court where the candidate belongs. Notary is not allowed.
