Online Application & Fee Payment for the External Theoretical & Sessional Examinations for the even semester diploma students (New Syllabus)	<ul style="list-style-type: none"> • All eligible even semester diploma students under New Syllabus (Academic Session 2023-24) of Engineering & Technology/Architecture/MOPM will have to fill up Application Form for the upcoming External Theoretical & Sessional Examinations through the web-portal of the Council at www.webscte.co.in by paying requisite fee. • A link captioning "Apply Online for External Theoretical & Sessional Examinations for the Even Semester Students of Diploma in Engineering & Technology/Architecture/MOPM (June 2024)" will be activated in the Home Page of the Council's website, www.webscte.co.in on 10th May, 2024 for the concerned students. • Eligible students will have to enter their Registration Number after clicking the above-mentioned link for initiating the process of form fill-up. • Students will have to provide their mobile number and email id in the given space and will have to click the tab "Submit and Pay Fees". • For payment of the fee, students have to select "Mode of Payment" from Net Banking, Debit Card, Credit Card or UPI and pay the fee. • Regular students will have to pay fee of Rs. 250/- (Rupees two hundred and fifty) only and Casual students will have to pay fee of Rs. 150/- (Rupees one hundred and fifty) only. • Last date for submission of online form and payment of fee by the concerned students is 19th May, 2024 (Up to 11.30 PM). • After successful payment of the examination fee, application details of the students will automatically reach their respective Institute portal for online validation by the Institute authority. • During payment of the fee, if online transaction of any student shows 'PENDING' for a prolonged time, he/she has to write immediately to the Council at helpdesk@webscte.co.in with full details and a screen shot of the transaction made. • Last date for online validation of the eligibility of the students by the Institute authorities is 20th May, 2024 (Up to 11.30 PM).
