## NOTICE

Sub: Withheld of Result Publication for Diploma in Pharmacy (Part-I) Examination, November-2024 of 5 (Five) Diploma in Pharmacy Institutions

In terms of this Council's Notification under Memo No. WBSCTVESD/TED/2024-25/2528 dated 06.11.2024, the Theoretical External Examinations for the students of Diploma in Pharmacy (Part-I) for the Academic Session 2023-24, are being conducted from 25.11.2024 at 37 (Thirty Seven) different Away Examination Centres (Government Polytechnics and Industrial Training Institutes) as per letter issued by the Council under Memo No. WBSCTVESD/TED/2024-25/2531 dated 06.11.2024.

Some media reporting has come to the notice of the Council regarding adoption of unfair means and malpractices by the students of some Diploma in Pharmacy Institutes, whose examination centre was allotted at Arambagh Government Polytechnic, Chandur.

In view of the above, it has been decided that Council will make thorough inspection/investigation of the reported incident and review reports of the Centre-in-Charges and the Observers of all 37 examination centres for unveiling the actual fact, stated to be happened in Arambagh Government Polytechnic, Chandur during the Diploma in Pharmacy (Part-I) Examination (November 2024) as per reporting made by the media persons. Now it is also decided that the **results for the students of following five institutions**, whose examination centre was allotted at Arambagh Government Polytechnic, Chandur, shall remain 'WITHHELD' pending further action in this regard.
