- 1) For casual students, the Supplementary Practical Examination will be held at Out Centre (Nodal Center) for Compulsory Academic Papers and Optional Elective Papers.
- 2) **Fixation of the Schedule of Examination:** The Nodal in Charge will prepare the schedule of the External Practical Examination as mentioned in Sr. no (1) above in coordination with Nodal Officer regarding the External Examiner and intimate the Head of the Institutes of the Participating Institutes (PI) about the date & time of the examination program for intimating the same to the candidates.
- 3) **Attendance in Examination:** Attendance of the examinees for the Practical Examination should be recorded in **Marks Foil cum Attendance sheet**. Hard Copies of duly filled **Marks Foil cum Attendance sheet** are to be submitted to the Council. Nodal Centre retaining the copy for your office record for future use as and when required. Please ensure that no additional names are to be incorporated in the preprinted **Marks Foil cum Attendance sheet** without instruction/approval from the Council / Nodal Centre.
- 4) **Appointment of External Examiner and also arrangement for Sessional / Practical Examination**
External Examiners are to be selected by Nodal Officer in consultation with the Nodal in-Charge of the Centre and appointment letter duly countersigned by the Nodal Officer is to be issued to the External Examiner. The letter is attached in ANNEXURE A.
