**NOTICE**

This is to inform all eligible students & Head of the institution of vocational training centers that online application for Post Publication Scrutiny (PPS) of Answer Scripts of Higher Secondary (Voc.) Exam, 2022 will be commenced from 16.06.2022. Before application you are requested to note the followings carefully that,

1. With e-marksheets, eligible students will be able to apply for "**Post Publication Scrutiny (PPS)**" of their answer Scripts of theoretical papers of class XII from **16.06.2022 to 28.06.2022** through his/her Vocational Training Centre [VTC] from where he/she was enrolled for Higher Secondary(Voc.) exam, 2022.
2. Applications for **Post Publication Scrutiny (PPS)** can only be made through online (<http://wbscvetpps.org.in/NEWSYLLABUS/>) by the VTC on behalf of intended applicants. Any other mode of submission of application will not be accepted.
3. Requisite fees for **Full paper** (i.e. full marks above 50): **Rs.40.00 per paper** and **Half paper** (full marks less than & equal to 50): **Rs.30.00 per paper**.
4. Intended applicants are requested to submit the PPS application fee to VTC and VTCs are requested to **deposit the fees** of all applicants to the Council through **SBI Collect portal** within **28.06.2022**. Without depositing requisite fees through SBI Collect, applications will not be considered as valid.
5. **Please carefully note the followings for payment of application fees for PPS through SBI collect:**  
I) while choosing -"Select Govt. Department", please select only- "**WBSCT AND VE AND SKILL DEVELOPMENT**"  
II) Similarly in "Select Category", please select, "**VED-VTC PPS application Fee HS (V) 2022**"
6. PPS applications duly signed by the candidates & Head of the VTC along with consolidated statement as generated from online PPS portal in duplicate showing particulars of students mentioning their **Roll, Name, subject codes** as applied for and **single SBI Collect e-receipt duly sealed & signed** must be submitted to the Nodal Office within **29.06.2022**. The nodal office to check consolidated statements & corresponding e-receipt of SBI collect & will send the same to the Council through speed post.
7. **In the event that the student has applied for (Post Publication Scrutiny) and also for Supplementary Exam, 2022 marks obtained by him/her in Supplementary Examination, 2022 will be considered as Final.**


