## ADMISSION NOTIFICATION FOR PDPC & PDME COURSES (ACADEMIC SESSION 2022-23)

Online applications are invited for admission to the following courses:-

Courses	Duration
1) Post Diploma in Petro Chemical Engineering (PDPC)	18-Months
2) Post Diploma in Medical Electronics (PDME)	18-Months

## **ELIGIBILITY**: Candidates must be an Indian Citizen.

1) Post Diploma in Petro Chemical Engineering (PDPC):

Passed Diploma examination with at least 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination as per Appendix – 1, sl. no 1.2 of Page 88 of AICTE Handbook 2022-2023.

2) Post Diploma in Medical Electronics (PDME):

Passed Diploma examination with at least 50% marks (45% marks in case of candidates belonging to reserved category) in the qualifying examination as per Appendix – 1, sl. no 1.2 of Page 88 of AICTE Handbook 2022-2023.

<u>RESERVATION</u>: Reservation of seats for SC, ST, PC (Physically Challenged or Handicapped) and other category (if any) candidates in Government level Institutes will be as per norms of the Government. Candidates have to produce their original SC, ST, PC or other category (if any) Certificates issued by the Competent Authority of the state of West Bengal at the time of counselling and/or admission. SC/ST candidates of States other than West Bengal will not get the benefit of such reservation.

<u>APPLICATION</u>: Online application portal for admission to the aforesaid courses will be activated on the Council's website <u>sctvesd.wb.gov.in</u> from <u>03.01.2023</u>.

Last date for online application is 14.01.2023.

## **APPLICATION PROCESS:**

An applicant should ensure that he/she satisfies the requirements relating to Age Limit, Educational Qualification, etc. before submission of the application. The application will be automatically rejected if a candidate does not fulfil these requirements. Any candidate, found not in full conformity with his/her submitted information at the time of verification of original testimonials, will not be allowed admission even though he/she secures a rank in the merit list. Application will have to be filled-up properly and completely in all respect. No request for subsequent change in information submitted by the candidate will be entertained under any circumstances. The Council is not liable for refusal of admission to a candidate by the institutes even after being merit listed for wrong submission of information by the candidate.

PREPARATION OF MERIT LISTS: The merit lists of all the aforesaid courses will be prepared based on the marks obtained & submitted by the candidates through web portal. No subsequent changes in the submitted marks will be entertained in any circumstances. The modalities for preparation of merit lists will be as per order of the government.

RANK CARD: After preparation of merit lists, the applicants can download their Rank Card from Council's website by providing their application form number.

<u>ADMISSION</u>: Admission of candidates to the Institutions mentioned under <u>Annexure</u> below will be made from the merit listed candidates through centralised / Institute level counselling, on offline mode.
