

All HOI are advised to keep two copies (i.e Council & Computer) of printed pre-filled consolidated Marks statement (CMS) in their custody for further reference and signed by the HOI(Nodal Copy) submitted by the School to the respective Nodal Centres within **09.08.2023**

Please note that Manual correction in filled-in marks statements in any form will not be accepted.

In the portal, the school is to enter actual marks obtained by the students in each subject w.r.t. given full marks of the subjects in the marks column provided for each student. The HOI is strictly instructed to personally check each Theory/Practical/Project Marks obtained by the student w.r.t. Full Marks as per course the curriculum of each subject against the Name & Registration/Roll no. of the students mentioned in the marks foils for online marks entries, so that no mistake may take place during the entry of Theory Marks against the students.
