The bid should be addressed to the CAO, WBSCT&VE&SD and to be submitted at above mentioned address on or before 27/02/2023 by 2.30 p.m. Quotation will be opened on the same day at Karigari Bhawan at 4: 00 p.m. Any participating bidder or his/her authorized representative (who is to be authorized in writing) may remain present when such quotation paper will be opened.

#### Eligibility Criteria :-

- 1) The Bid Document should contain
- i) Self attested copy of Valid Trade License
- ii) Self attested copy of PAN Card of Company
- iii) Self attested copy of Professional Tax Clearance Certificate.
- iv) Certificate of authorized service provider / OEM of the Company.

#### GENERAL TERMS OF CONTRACT: -

- 2) The rate quoted will have to be inclusive of all charges whatsoever.
- 3) The Council reserves the right to cancel any or all the tenders if so required without assigning any reason thereof.
- 4) The execution of the job has to be done within 7 days after issuance of work order. Failing which the work order will be cancelled and order will be given to next lowest eligible bidder without assigning further reason.
- 5) Payment will be made within 15 days after execution of job.

**Security Deposit: - Successful** bidder has to submit 5% of bid value as bank guarantee before issuance of work order as security Deposit.

**Termination of Contract:** - The contract will be terminated if the selected vendor fails to deliver the services within the stipulated time period.

**Penalty:-** 0.2 % of the bid value will be imposed as penalty if the vendor fails to deliver and install within the specified time. Failure to comply after that will result in cancellation of bid and cessation of security deposit. Company may be backlisted and debarred from participation of tender process of WBSCT&VE&SD.

**Settlement of Dispute:** - Any dispute arising in this regard will be settled under jurisdiction of Barasat Court, West Bengal.
