#### Eligibility Criteria :-

- 1) The Bid Document should contain
- i) Self attested copy of Valid Trade License
- ii) Self attested copy of PAN Card of Company
- iii) Self attested copy of Professional Tax Clearance Certificate.
- iv) Certificate of authorized service provider of the Company.

### GENERAL TERMS OF CONTRACT: -

- 2) The rate quoted will have to be inclusive of all charges whatsoever.
- 3) The Council reserves the right to cancel any or all the tenders if so required without assigning any reason-thereof.
- 4) The execution of the job has to be done immediately after issuance of work order. Failing which the work order will be cancelled and order will be given to next lowest eligible bidder without assigning further reason.
- 5) Payment will be made within 15 days after execution of job.

**Termination of Contract:** - The contract will be terminated if the selected vendor fails to deliver the services within the stipulated time period.

**Penalty:-** 10% of the bid value will be imposed as penalty if the vendor fails to serve as per requirement, Company may be backlisted and debarred from participation of tender process of WBSCT&VE&SD.
