SUPPLEMENTARY EXAMINATION NOTIFICATION-2022

Sub: Guidelines to conduct Higher Secondary (Vocational) supplementary Examination-2022

In continuation to the Notification Vide SCTVSD-14014/1/2020-ACC OFFCR(WBSCTVESD/ 2022-23 /2062 Dated: 12.05.2022 the following are the guidelines to be followed for the Supplementary Examination to be held in 2022.

1. All the HOIs will be responsible for informing their wards who have failed in Higher Secondary (Vocational) Examination of the opportunity to appear for supplementary Examination in 2022. The Registration for Supplementary Examination will start from 22.06.2022 and will continue till 28.06.2022 (both days inclusive).
2. Every effort should be made to ensure that candidates whose name features in the list of Supplementary Exam may appear for the same. The schedule for supplementary exam will be sent by 28th of June 2022.
3. The list of students and the subjects for which they may appear for Supplementary Examination will be provided by the Council.
4. All students who are eligible for Supplementary Examination but has not appeared at 'Environment Studies' paper, he /she will be eligible to appear at supplementary examination of this paper. These students will have to appear for **Environmental Studies**. Failure to appear for **Environmental Studies** will not Pass the Exam even if they pass the subjects in the Supplementary Examination.
5. Supplementary examination will be treated as an opportunity offered by WBSCTVE & SD to all unsuccessful candidates (Regular / casual / continuing) to pass Higher Secondary (Vocational) who have appeared in mandatory subjects but failed in maximum two of the five subjects in which students are required to pass.
6. Similarly, students who have been declared "Failed" just due to non-submission of projects will be given another opportunity to submit their projects so that marks for the same can be included in the mark sheet. List of students eligible to submit Projects will be given by Council.
7. In the event that the student has applied for PPS (Post Publication Scrutiny) and also for Supplementary Exam, marks obtained by him in Supplementary Examination will be considered as Final.
8. Notice for schedule and other procedure for conducting supplementary examination will be published by WBSCTVE & SD along with the time table for the exam schedule and issued at a later date.
