On behalf of West Bengal State Council of Technical & Vocational Education & Skill Development examinees of Higher Secondary (Vocational) Examination -2024 are hereby informed that-

1. Examinees will be able to apply for "Post Publication Scrutiny (PPS)" of their answer Scripts of theoretical papers of class XII from **14.05.2024 to 24.05.2024** through his/her Vocational Training Centre [VTC] from where he/she was enrolled for the examination.
2. Applications for Post Publication Scrutiny (PPS) can only be made through online (<http://wbscvetpps.org.in/NEWSYLLABUS/>) by VTC on behalf of intended applicants. Any other mode of submission of application will not be accepted.
3. Requisite fees for full paper (**full marks above 50**): **Rs.40.00 per paper Half paper (full marks 50 & below): Rs.30.00 per paper.**
4. Intended applicants are requested to submit the PPS application fee in cash to VTC and VTCs are requested to deposit the fees of all applicants to council through SBI Collect portal with in 24.05.2024. Without depositing fees through SBI Collect, applications will not be considered as valid.
5. The generated from the online PPS portal, PPS applications duly signed by candidates & Head of the Institute along with consolidated statement in duplicate showing particulars of students mentioning their Roll, Name, subject codes they have applied for PPS etc. and as and single SBI Collect e-receipt duly sealed & signed must be submitted to the Nodal Office with in 27.05.2024.
